Sub:- Recognition/approval of Punjab Institute of Medical Sciences, Jalandhar, Punjab for the award of MBBS degree(150 seats) granted by Baba Farid University of Health Sciences, Faridkot u/s 11(2) of the IMC Act, 1956.

Sir,

I am directed to inform you that the matter with regard to recognition/approval of Punjab Institute of Medical Sciences, Jalandhar, Punjab for the award of MBBS degree(150 seats) granted by Baba Farid University of Health Sciences, Faridkot u/s 11(2) of the IMC Act, 1956 alongwith notification dated 08.09.2016 issued by the Central Govt. was considered by the General Body of this Council at its meeting held on 22.11.2016 and it was decided as under:-

"The General Body of the Council noted that the Executive Committee of the Council at its meeting held on 30/06/2016 had decided to recommend to the Central Government for recognition/approval of Punjab Institute of Medical Sciences, Jalandhar, Punjab for the award of MBBS degree(150 seats) granted by Baba Farid University of Health Sciences, Faridkot u/s 11(2) of the IMC Act, 1956.

*"The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April 2010 and act accordingly at appropriate time, which reads as under:-
8 (3) ...*

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute..."

It was also pointed out that the matter was yet to be placed before the General Body of the Council.

In the meantime, the Central Govt., Ministry of Health & Family Welfare vide notification dated 08/09/2016 has granted conditional recognition of the college on the recommendations of the Supreme Court mandated Oversight Committee on the following conditions:-

"1. This Notification is issued complying with the direction of the Supreme Court Mandated Oversight Committee on MCI as communicated vide letter No. OC/Approvals for 2016-17/61 dated 29.08.2016. The Medical College shall within 15 days of this Notification, provide the following:-

- (i) An affidavit from the Dean/Principal and Chairman of the Trust/University/Society/Company etc concerned, affirming fulfillment of all deficiencies and statements made in the respective compliance report submitted to MHFW by 22 June, 2016,*
- (ii) A bank guarantee in the amount of Rs. 2 crore in favour of MCI, which will be valid for 1*

year of until the first renewal assessment, whichever is later. Such bank guarantee will be in addition to the prescribed fee submitted alongwith the application.

2. The Supreme Court Mandated Oversight Committee while granting approval has also stipulated as follows:-

- OC may direct inspection to verify the compliance submitted by the college and considered by OC, any time after 30 September 2016.
- In default of the condition (i) and (ii) 1 above and if the compliances are found incomplete in the inspection to be conducted after 30 September 2016, such college will be debarred from fresh intake of students for 2 years commencing 2017-18.

3. The recognition so granted to undergraduate courses for award of MBBS degree shall be subject to directive and stipulations made by the Oversight Committee indicated herein above and further subject to a maximum period of 5 years, upon which it shall have to be renewed.

4. The procedure for 'Renewal' of recognition shall be same as applicable for the award for recognition.

5. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned undergraduate Course."

In view of above, the General Body expressed that the Council recommends permission/recognition of any course in modern medicine only when it fulfills the requirements specified in the MSR in the interest of quality of medical education. The responsibility to ensure the quality of medical education is upon all authorities responsible for the implementation of IMC Act, 1956."

In view of above, you are, therefore, requested to take appropriate action in the matter.

Subject: Conditional Recognition granted in 2016-17 – Permission for admission of Fresh Batch in MBBS Course for academic year 2017-18 at Punjab Institute of Medical Sciences, Jalandhar.

Sir/Madam,

In continuation to this Ministry's notification dated 08.09.2016 granting conditional recognition to Punjab Institute of Medical Sciences, Jalandhar for award of MBBS degree for 150 intake on the basis of approval communicated by Supreme Court Mandated Oversight Committee on MCI (OC) and after considering the decision dated 30.06.2016 of MCI's Executive Committee to recommended to the Central Government for recognition/approval of the College which was noted by the General Body of MCI in its meeting dated 22.11.2016, I am directed to convey the approval of the Central Government allowing the college to admit Fresh Batch of 150 students in the MBBS course for the academic year 2017-18, pending decision on the conditional recognition.

2. The permission is valid for one year and for admitting only one batch of 150 MBBS students during the academic session 2017-18. The next batch of students in MBBS course will be admitted in the college only after the conditional recognition is confirmed.

3. The Government Medical Colleges (except those located in J&K, Andhra Pradesh & Telangana States) shall contribute 15% of MBBS seats for which the renewal permission is granted for all India quota.

4. Admissions made in violation of the above conditions will be treated as irregular and action will be initiated under IMC Act & Regulations made there under.
